



Memorial University of Newfoundland Faculty of Nursing Tenure Track Positions

Memorial University Faculty of Nursing invites applications for **three** tenure-track positions at the rank of Assistant or Associate Professor, effective August 1, 2021 [negotiable]. These positions are subject to final budgetary approval.

Memorial University is the largest university in Atlantic Canada. As the province's only university, Memorial plays an integral role in the education and cultural life of Newfoundland and Labrador. Offering diverse undergraduate and graduate programs to almost 18,000 students, Memorial provides a distinctive and stimulating environment for learning in St. John's, a safe and friendly city with great historic charm, a vibrant cultural life, and easy access to a wide range of outdoor activities.

The Faculty of Nursing is located on the university campus and offers programs leading to a Bachelor of Nursing (four-year and accelerated options), a Master of Science in Nursing (practicum and nurse practitioner options), a Post Master's Nurse Practitioner Graduate Diploma, and a PhD in Nursing. The undergraduate program has recently been revised and a concept-based curriculum has been implemented.

A completed earned PhD degree is required to receive the rank of Assistant Professor and to be in a tenure-track position. If a successful candidate has not completed a PhD degree, they may be appointed to a regular term, non-renewable three-year appointment at the rank of Assistant Professor. If the candidate completes all of the requirements for the PhD degree during the first 24 months of the term appointment, they shall begin a tenure-track appointment following completion of the requirements of the degree.

Two positions are designed for faculty members who completed a dissertation using quantitative research methodology and/or has a program of research using quantitative research methodology, and can teach statistics and/or quantitative research methods in our graduate programs. Position responsibilities include teaching and supervision in the undergraduate and graduate programs and conducting a program of research and academic service. The successful candidate must be eligible for licensure with the College of Registered Nurses of Newfoundland and Labrador as a Registered Nurse and/or as a Nurse Practitioner and hold a master's degree and an earned PhD degree. The master's or PhD degree must be in nursing.

The successful candidate must demonstrate evidence of a beginning program of scholarship including research using quantitative research methodology, publications, and external funding. Candidates must also be prepared to teach in the undergraduate and graduate programs and thus must have relevant clinical experience. A minimum of two years of clinical experience in an area of nursing as a Registered Nurse is required to teach in this area in the undergraduate program. If the successful applicant is a Nurse Practitioner, they require a minimum of three years of experience as a Nurse Practitioner, and preferably five years, to teach in the nurse practitioner program.

One position is for a faculty member who can teach pediatrics and who is a Registered Nurse and/or a Nurse Practitioner. Position responsibilities include teaching and supervision in the undergraduate and graduate programs, conducting a program of research, and academic service. The successful candidate must be eligible for registration with the College of Registered Nurses of Newfoundland and Labrador as a Registered Nurse and/or as a Nurse Practitioner and hold a master's degree and a PhD degree. The master's degree or PhD degree must be in nursing. PhD candidates who are near completion of their degree may also be considered.

The successful candidate must demonstrate evidence of a beginning program of scholarship, including research, publications, and external research funding. Candidates must also be prepared to teach in the undergraduate and graduate programs and thus must have relevant clinical experience. A minimum of two years of clinical experience in an area of nursing as a Registered Nurse is required to teach in this area in the undergraduate program. If the successful applicant is a Nurse Practitioner, they require a minimum of three years of experience as a Nurse Practitioner, and preferably five years, to teach in the nurse practitioner program. We are particularly interested in applicants who can also teach statistics and/or quantitative research methods in our graduate program.

All successful applicants must hold a current practicing license with the College of Registered Nurses of Newfoundland and Labrador (CRNNL), provide a criminal records screening, and vulnerable sector check; and, an up-to-date immunization record.
