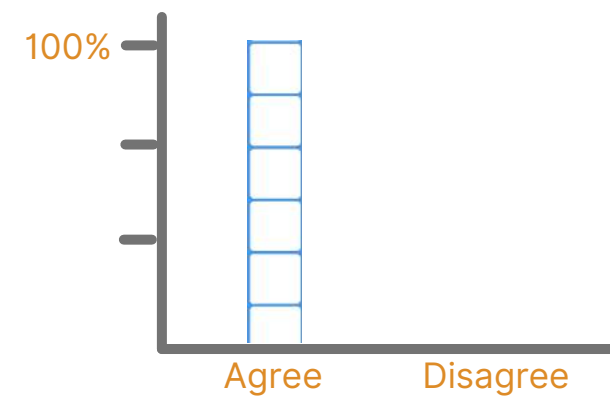

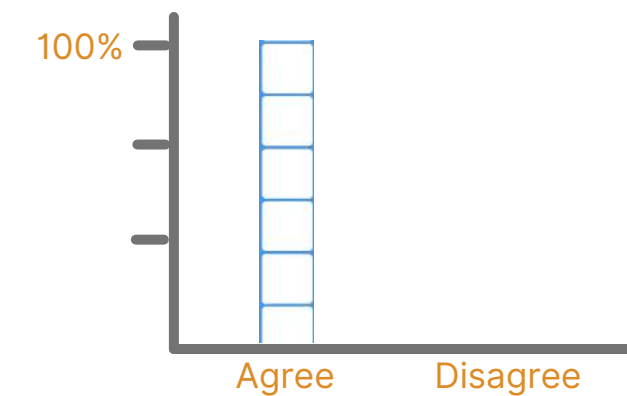
Did Verified reduce the burden for compliance checking?

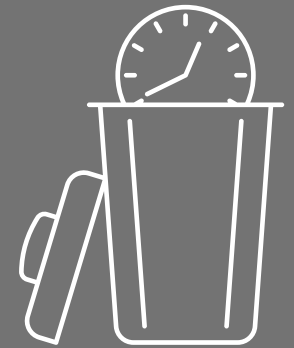

Challenge 1

Time Drain



It takes considerable time to navigate and streamline complex student placement requirements in the face of tight deadlines.

At the same time, ensuring *continuous* verification and compliance of health and other personal documentation of students demands additional time.

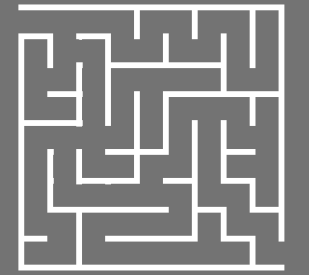

Challenge 2

Ineffective Systems



There are cumbersome logistics between schools and placement agencies such as:

- changing guidelines and requirements
- separate clearance processes
- several departments involved

This results in standardization issues, procedural gaps, and misplaced liabilities.

Challenge 3

Exposed Risks



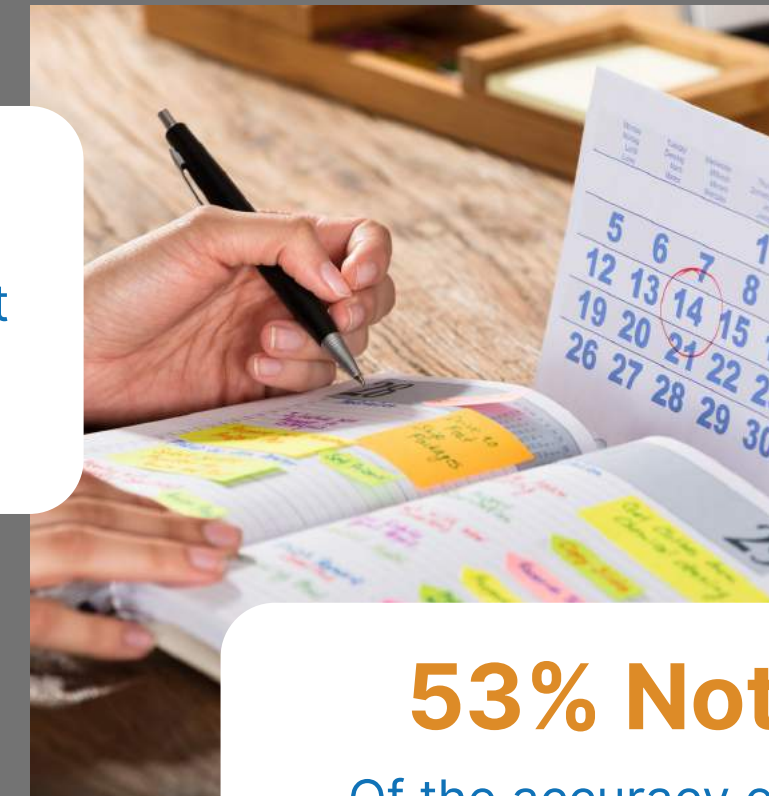
When time is short and requirements complex, there is inevitably a heightened risk of human error in data accuracy, privacy and confidentiality.

Mismanagement of compliance presents a serious risk/exposure from both internal and external governing or licensing bodies.

In addition it leads to a lack of focus on planned objectives and accountability.

report having minimal internal audit processes for verifying the placement documents



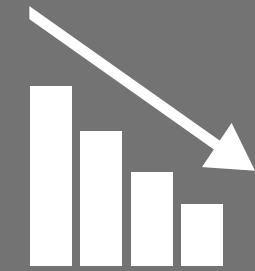

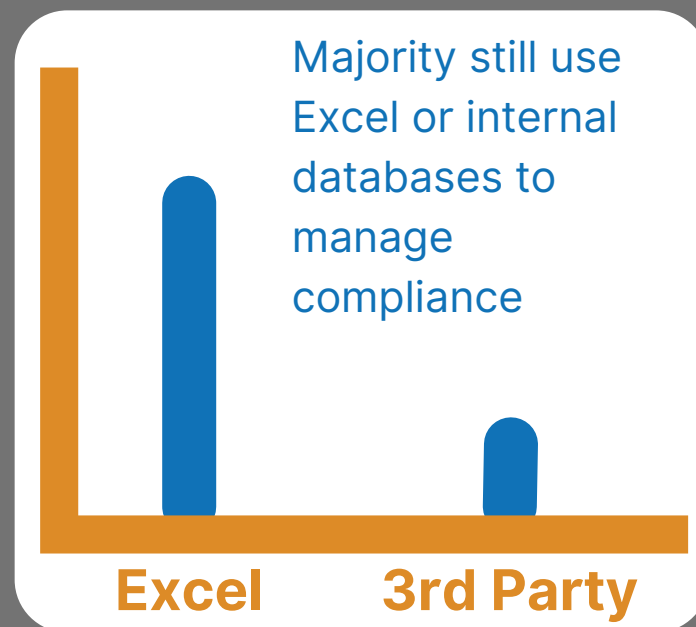
Challenge 4

Poor Compliance



Inefficient document processing and an absence of automated tracking of clearance status mean critical student time is wasted waiting in person or facing delays in an online system.

The result of this hybrid process is that deadlines for placements are missed, again leading to lower compliance rates.

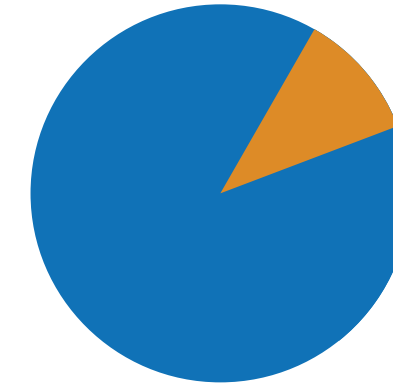
Challenge 5

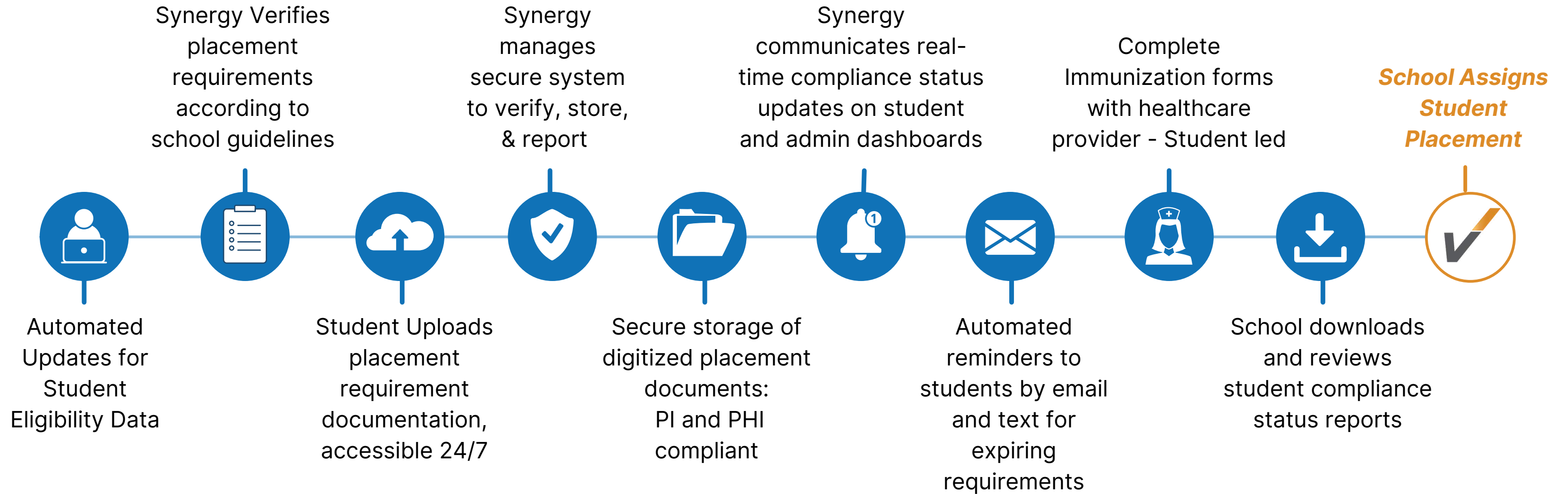
