# Call for an Evaluator

## **Climate Driven Infectious Disease Project**

The Canadian Association of Schools of Nursing (CASN) is seeking an evaluator for the Climate- Driven Infectious Disease (CDID) project. The evaluator will be responsible for developing evaluation tools to assess the immediate impact of the CDID project knowledge products and the impact of the project.

### **Background**

CASN is carrying out a three-year project, funded by the Public Health Agency of Canada, to prepare the next generation of nurses to address climate-driven vector-borne diseases (VBDs). In partnership with the Canadian Alliance of Nurse Educators Using Simulation (CAN-Sim), CASN has develop a series of interactive simulations to showcase the critical role nurses play in navigating the health impacts of the climate crisis. CASN is also revamping the existing VBD e-resource and guidelines for nursing education so that it contains up-to-date evidence on climate-sensitive VBDs in Canada.

## **Scope of Work**

The selected evaluator will be responsible for:

- 1. Reviewing key project documents (proposal, workplan), knowledge products, and will meet with CASN staff and the Advisory Committee Chair to understand the purpose of the evaluation and inform the creation of the evaluation questionnaires;
- 2. Creating an evaluation plan with details on questionnaires to be developed;
- Developing four evaluation questionnaires tailored to the project objectives and knowledge products;
- 4. Analyzing responses from respondents using appropriate methods; and,
- 5. Preparing and submitting a final report summarizing key findings of the evaluation.

#### CASN is responsible for:

- 1. Providing demographics-related questions to be included in the questionnaires;
- 2. Translating the questionnaires into French;
- 3. Inputting the questionnaires into CASN's online survey evaluation tool (Qualtrics) and distributing the questionnaires; and,
- 4. Providing the evaluator with the data for analysis.

#### **Timeline**

The contract will be from November 1, 2025 – March 31, 2026. The breakdown of the schedule is as follows:

- Milestone 1: Review materials and meet with CASN November 2025
- Milestone 2: Submission of 3 evaluation questionnaires December 17, 2025
- Milestone 3: Submission of the final report (approximately 12-15 pages) March 27, 2026

## **Payment**

The total budget for the evaluation contract is \$6,000.00 (including HST if applicable). The evaluator will be paid 50% upon completion of Milestone 2. The remainder of the contract will be paid upon completion of Milestone 3.

## Applicant's cover letter should include:

- A brief description of the individual's past experience developing questionnaires for similar projects and other research and evaluation experience
- Confirmation that the individual can meet the project timeline
- Demonstrated relevant experience and a strong interest in public health nursing, environmental health/planetary health nursing. Relevant experience may include clinical practice, education, training, policy development, or research.
