

The School of Nursing in the Faculty of Health at York University invites highly qualified applicants for an Assistant Professor, Nurse Practitioner. This is a tenure-track appointment to the Professorial Stream to commence July 1, 2026.

The successful candidate will have a robust program of research, be a practicing Nurse Practitioner, and be able to teach in the Nurse Practitioner program across courses. The candidate must also be willing to contribute to service to support the NP program.

### **Candidate Qualifications:**

- **Degree:** PhD or equivalent doctoral degree in Nursing or a related field by the appointment's start date. Candidates must be registered in good standing or eligible for registration with the College of Nurses of Ontario by the appointment's start date.
- **Scholarship:**
  - A coherent and well-articulated program of research and specialization in clinical care, education and/or policy in health.
  - A record or evident promise of generating innovative, substantive, rigorous, and as appropriate, externally funded research and/or research creation.
  - A record or evident promise of making influential contributions and demonstrating excellence in the field (e.g., securing external funding and the publication of scholarly papers, chapters, books, and/or monographs).
- **Teaching:**
  - A record or evident promise of excellence in teaching at the university level and dedication to students (e.g., pedagogical innovation, student and/or peer evaluations of teaching, awards, or other indicators of high-quality teaching (Nurse Practitioner level preferred)).
  - Ability to facilitate educational content as a generalist Nurse Practitioner, graduate or undergraduate education
  - Suitability for prompt appointment to the Faculty of Graduate Studies, given that the position will involve graduate teaching and supervision.
- **Additional:** Evidence of curriculum development at the graduate level preferred.

- Salary will be commensurate with qualifications and experience.
